

Immigrant Workers Find OSARCer Appealing

The Summer, 2002 issue of Work History News, the newsletter of the New York Labor History Association notes the work of OSARC member Joel Leichter in providing representation to immigrant workers who are being denied unemployment insurance benefits. Leichter works with the Workers' Defense League in handling these appeals.

LaborFilms

OSA's labor film series returns this Fall with Salt of the Earth on September 20th, Each LaborFilms screening starts at 7pm in Room 709 at the union office, 220 East 23rd Street (between 2rd and 3rd Aves) and will be followed by an informal discussion. Light refreshments will be available.

Salt of the Earth [94 minutes, US, 1954/ Chicano miners in a small New Mexico town strike for better working and living conditions. Their strike is on the verge of collapse when the local's "Ladies Auxiliary" takes up the battle, turning the tide. Made by blacklisted Hollywood creative workers, the film was



produced under extremely adverse production conditions with a mixed cast of professionals and unionists. Vigilante attacks on the crew and the deportation of the lead actress to Mexico were only some of the obstacles.

The series continues October 4th with Controlling Interest [45 minutes, US, 1978], a pioneering documentary exploring the impact of transnational corporations on global affairs. Corporate executives frankly reveal the reasoning behind corporate globalization. Also to be screened is ZonedForSlavery [1995, 20 min. USA] which exposes child and sweatshop labor around the world, subsidized by U.S. taxpayers.

Then, on October 18th, The Uprising of '34 /90 minutes, US, 1995] is an in-depth examination of the largest single-industry strike in American history, the General Textile Strike of 1934, which saw more than 400,000 workers on the picketline. Combining interviews with remarkable archival footage, the film weaves a tale all the more remarkable because the bulk of the strike involved Southern workers, long thought to be "immune" unionization. The legacy of the strike for organizing the South is also examined.

November 1st we'll screen At The River I Stand, [56 minutes, US, 1993/ about the Memphis Sanitation strike of 1968, which revealed the connections between economic and civil rights in a deeply racist community. When 1300 municipal workers, paid so little they qualified for welfare, struck for higher wages and a union contract, Dr.Martin Luther King joined the campaign in what would be his final non-violent challenge to the white power structure.

November 15th, traces the story of the women who formed the backbone of the great General Motors Sit-Down Strike in Flint, Michigan in 1937, a strike that solidified the formation of the United Auto Workers Union. Clips from Roger and Me. Michael Moore's scathing portrait of Flint a half century later will also be shown.

Prescription Drug Rider Reimbursement

Negotiations with the City last year produced an agreement for a one time payment to help defray the cost of prescription drug riders. Checks went out on August 1th. Those who retired on or before December 31, 2000 should have received a check from OSA for \$125. Those who retired after that date but on or before June 30, 2001 should have received a check for \$75.

Please note that the OSA Welfare Fund already pays the drug option premium on behalf of Medicare Part B participants and their spouses/domestic partners in whole or in part. If you are already being reimbursed in this fashion, no additional reimbursement is due you,

A reminder: To enroll in a Medicare HMO or other Medicare Health Plan you must complete a special application directly with the health plan you seek to join. A copy of this application is then sent to the City Health Benefits Program by the Health Plan. When you enroll, identify yourself as a City employee. Information on the approved plans is available from the Health Benefits Program.

The COMRO Report


Jim McKeon delivered an abbreviated COMRO report at the June luncheon and reunion.

Jim reported he had introduced a resolution for COMRO support that would extend eligibility for membership in a specific employer's credit union to any retiree receiving a pension from that employer. At present, retirees are excluded from credit union membership by New York State law.

COMRO chair Larry Kaplan reported at the June COMRO meeting that NYS Senate Majority Leader Joe Bruno had responded to a COMRO letter supporting Senate Bill S1104A. The bill, which would mandate the cost of drugs in New York State could be no higher than those sold in any other jurisdiction, is now under review in the Senate Committee on Codes, according to Bruno.

Kaplan reported on a year 2001 investigation of the political influence of the pharmaceutical industry in Congress compiled by Public Citizen and the Center for Responsive Politics. As the chart below shows, the drug companies spent \$1.77 million in lobbying and \$20 million more on campaign contributions in that year, more than any other industry. The drug companies employed 625 lobbyists and paid each an average of \$12,000 a month. They spent additional millions on gifts, meals, and trips for doctors and still more on free drug distributions to induce doctors to write for their specific drugs.

Spending on prescription drugs in 2001 totaled \$175.2 billion up 17% from 2000. Drug companies receive a 20 year monopoly on profits from drugs they patent, although more than half of all research costs are





paid by tax dollars and in some cases. AIDS drugs for example, research is fully paid by tax dollars.

Industry lobbyists have effectively blocked a Medicare prescription drug benefit thus far. The Senate failed to agree on any drug coverage before adjourning in July.

The industry has also strenuously fought any limits on industry profits.

Paul Henry at OSARC's 10th For example, Maine passed a law that would allow it to impose price controls on drugs if the drug companies refused to discount drugs for the 325,000 uninsured low-income state residents not covered by Medicaid. The industry then threatened to stop distributing drugs in the state and later filed suit against the law.

Love Me When I'm 64? According to a study by the UN Population Division cited by COMRO, ten percent of the world's population was 60 or older in 2000, By 2050, twenty-one percent will be that age.

Meanwhile, the U S population is graving as well. At the turn of the 20th century, almost 3 million Americans were 65 or older, Today, 35 million are 65 or older, 1.4 million of them in their 90's and 64,000 of them 100 or more.

Medicare Part B Reimburgement

Payments for the full reimbursement of Medicare Part B premiums have begun to emerge from the City treasury. These were long-delayed by the battle over the plan between former Mayor Giuliani and the City Council. The dispute was pulled back from the brink of court action earlier this year when Mayor Bloomberg reversed his predecessor's official opposition.

July 31", the City mailed checks for up to \$80.40 to approximately 100,000 retirees. The payment represented the balance due these retirees for full Part reimbursement for the year 2000. The adjustment equaled \$6.70 additional for each month in 2000 that a retiree and/or an eligible dependent were enrolled in Medicare Part Armory. B and a health plan



through the City Health Benefits Program, Late in August, the City is to mail another check - up to \$600 covering the full reimbursement of Medicare Part B Premiums for the year 2001.

Ouestions about Medicare Part B Reimbursement can be directed to the City of New York, Office of Labor Relations, Health Benefits Program, 40 Rector Street, 3rd Floor, NY NY 10006 (212) 513-0470. Don't forget to notify them in writing when you reach age 65, if your address changes or if a recipient dies.

A reminder: Some retirees are failing to file the proper form with the Health Benefits Program to receive reimbursement of Medicare Part B premiums. The Medicare Reimbursement Form is available for downloading on the OSA website (www.osaunion.org) Go to the "OSARC" section and click on the Medicare Reimbursement Form" link. Not web-connected? Request the form from Health Benefits.

Lung Power

The earlier lung cancer is detected, the more likely treatment will be effective. A new test offered by the New York Early lung Cancer Action Project can spot nodules that may be early signs of cancer years before they'd be detected on a traditional chest x-ray.

The twenty second test, done by Low-Dose Screening CT Scanner is available free for those who are 60 years of age or older, have a history of smoking for at least ten years, have no prior cancers of any type and are in good health.
